

# North Atlanta Equestrian Obstacle Challenge

March 18<sup>th</sup> \* May 20<sup>th</sup> \* June 24<sup>th</sup> \* September 9<sup>th</sup> \* October 28<sup>th</sup>

Registration Opens at 9:30 a.m. Competition Starts at 10:30 a.m. The challenge consists of 10 to 15 obstacles such as water, side-pass, tarps, noodles, bridges, back through, dragging and other interesting obstacles. Horses will be scored on how well they negotiate each one.

Divisions - Warm-up, In-hand, Youth, Novice, Open. In-hand has 3 divisions: Youth, Novice and Open. Multiple judges may allow several horses to be on course at one time. Prizes & ribbons in all divisions! Except warm-up (Participation ribbon only) Open to all horses, mules, and riders. Helmets required on all riders in the youth division. Warm-up classes may be done all day (in between any classes). There will be a time limit.

Entry Fee: \$30.00, Warm-up classes \$20.00 - Pre-entries suggested & appreciated – Order of go determined by receipt of entries– Early entries will get preference in order of go! Where you and your horse can have fun! Year-end buckles given in Youth, Novice, Intermediate, Open and In-hand. In-hand may do 2 in-hand classes for more points. Mustang Heritage Foundation has donated a buckle to the high point BLM mustang for the year.
